Safety and Health Consultation Service

The Office of Safety and Health Consultation provides free comprehensive on-site surveys for small and medium sized **private sector establishments** to identify potential workplace hazards, improve safety & health management systems, and assist in voluntary compliance with federal OSHA regulations.

All consultation services are voluntary and confidential. There are no fines, penalties, or fees associated with the service.

Consultation Service includes

- ◆ Safety and health appraisals of all mechanical and environmental hazards, and physical practices.
- ◆ Review of job safety and health programs, and assistance in establishing a customized safety and health program if not already in place.
- ◆ Workplace hazard identification and the appropriate corrective action recommendations to prevent a recurrence.
- ◆ Conference with management on findings.
- ◆ Written report of recommendations and agreements.
- ◆ Training and education with implementing recommendations.

"ABOUT"

Safety and Health Consultation Service

- ◆ The Office of Safety and Health Consultation is separate from federal enforcement and will **NOT** trigger an inspection.
- ◆ Consultants are advisers and provide recommendations. **THEY ARE NOT ENFORCERS!**
- ◆ Consultants conduct workplace visits by invitation only.
- ◆ Consultants are experienced safety and health professionals.
- ◆ Consultants are very knowledgeable regarding safety and health regulatory standards.

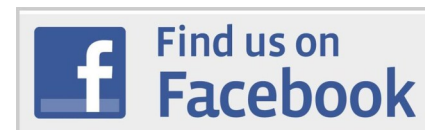
